- Examinations are conducted in a proctored online mode twice in a year.
- Examination fee is Rs. 500/- plus 18% GST per paper which is payable in advance by the due date as intimated to the participants before the examination.

Students are supposed to undertake 3-month internship project only after completion of 1st & 2nd Semester of P G Diploma Course under the guidance of a Mentor and submit project report followed by presentation before a panel of experts.
